Political Developments:

Kosovo-Serbia Dialogue

Kosovo PM Thaci announced that the topics discussed in the EU-mediated dialogue with Serbia have included: missing persons; parallel structures, Kosovo's membership in international organisations and forums; protection of Serb cultural and historical heritage in Kosovo; telecommunications The International Criminal Tribunal for the and energy; finalisation of decentralisation process; and the need to establish a municipality for North Mitrovica/ë and free elections in north Kosovo.

Thaci and Serbia PM Dačić met for a second time to discuss the normalisation of relations. Both sides agreed to have a joint technical working group to prepare feasibility study for the construction of a Pristina-Niš motorway and the need for transparency regarding the funding of parallel structures. The meeting also discussed how to Detention of KLA members enhance the protection of Serb cultural and religious heritage in Kosovo.

Alliance for the Future of Kosovo (AAK), has been appointed political coordinator for dialogue by initial ruling that had stopped the criminal Kosovo President Jahjaga.

Border Management

November to make final preparations for the detention on remand. Security in North Kosovo

November. There were several Serb protests opposing the reconstruction of Albanian homes in investigation. The conversations reveal what the Kroi i Vitakut/ Brdane neighbourhood of North senior PDK officials think of their party Secretary Mitrovica/ë. The road leading to the houses was General and speaker of parliament, Jakup blocked and there were violent clashes between Krasnigi. Serbs and Albanians.

In reaction to developments in the IBM negotiations, a grenade was thrown at border crossing, and Serbs blocked the Iber main road. Oliver Ivanović, former Secretary for the Ministry for Kosovo in the New Recognitions Government of Serbia, threatened that Serbs would oppose implementation of the IBM with protests, barricades and blocking roads. Political leaders in the north argue that implementation of the IBM

represents the establishment of inter-state borders.

Other incidents include the targeting of the deputy head of the Administration office in North Mitrovica/ë by an explosive device, in Zvečan/Zveçan.

ICTY acquittal of Haradinai

Former Yugoslavia (ICTY) acquitted three former Kosovo Liberation Army (KLA) commanders, including former PM Ramush Haradinaj, of all charges of committing war crimes and crimes against humanity in a retrial. The ICTY ruling received mixed international reactions due to concern for reconciliation and justice for victims, and Serbia has expressed anger at the verdict. In Pristina, Haradinaj received a hero's welcome

EULEX detained former KLA commander Fatmir Limaj a Democratic Party of Kosovo (PDK) Blerim Shala, a principal deputy leader for the deputy leader and 3 other former KLA fighters. The Supreme Court of Kosovo overturned an prosecution of Limaj and four of his fellow combatants for war crimes in Klečka. The case was returned to the District Court in Pristina. Three new recognitions of the Republic of Kosovo have been confirmed by Fiji, Timor-Leste and St. Kitts and Nevis. As a result. Kosovo now has 96 recognitions.

ECMI Kosovo Project Updates:

Empowering civil society to participate effectively in policy and decision-making processes through dialogue with government institutions

ECMI Kosovo is pleased to announce that on 26 November a new 2-year project 'Empowering Civil Society to Participate Effectively in Policy and Decision-Makina Processes through Dialogue with Government Institutions' began implementation. In cooperation with the 2 local NGOs, ECMI Kosovo will contribute to creating the necessary conditions for effective dialogue and partnership between civil society and government institutions at the local and central levels. Furthermore, the project will raise awareness of the role of civil society and the importance of its participation in decision and policy-making processes; increase trust between civil society and government institutions; strengthen civil society's capacities to effectively engage in policy and decisionmaking processes at the local and central levels; and foster inter- and intra-ethnic cooperation among civil society organisations (CSOs) in Kosovo.

Enhancing minority communities' understanding of Kosovo's electoral system

In October ECMI Kosovo began implementing the 2-month project 'Enhancing Minority Communities' Understanding of Kosovo's Electoral System' in partnership with IFES and 5 Kosovo NGOs. During November, ECMI Kosovo organised more than 10 public information meetings across Kosovo's municipalities, aiming to increase understanding of the electoral system and the importance of participation in the electoral process. Also, a 2-week campaign distributed leaflets in 7 municipalities. Furthermore, 4 TV debates were organised and broadcasted in minority languages and 3 promotional videos were recorded with members of non-Albanian/Serb minorities throughout Kosovo to be broadcast over 1 week on RTK minority broadcastings. Integration through learning of official languages in Kosovo

In November, ECMI Kosovo ended its 5-month language courses of Albanian and Serbian language for municipal officials in the 3 municipalities of Novo Brdo/ Novobërdë, Obiliq/ Obilić, and Štrpce/ Shtërpcë. A joint conversation class for course participants was also organised, during which they could jointly practice professional and daily situations in both languages. Participants who successfully passed the final test and regularly attended classes will be awarded with a certificate.



ECMI Kosovo met with the Office for Community Affairs, the Kosovo Institute of Public Administration and the relevant ministries to discuss policy measures to enhance knowledge and use of the two official languages in Kosovo municipalities. The results will be published as a policy brief in the New Year.

Improving the Delivery of Roma, Ashkali and Egyptian Education

In November, ECMI Kosovo participated in a twoday discussion on the education sector of the Action Plan on Roma, Ashkali and Egyptian Integration, hosted by MEST. The purpose was to review the monitoring framework so as to enhance reporting and measuring implementation, as well as to prioritize activities for the remainder of the Plan.

Knowledge Increase of the Socioeconomic Situation in Northern Kosovo

ECMI Kosovo's project team performed quantitative and qualitative analysis of the data collected in the field after obtaining 721 respondents. The final report will soon be published in Albanian, Serbian and English languages. It will cover the following areas of study: education, healthcare, social welfare, and economic development in North Kosovo.

This project is financed by the UK Foreign and Commonwealth Office, complementing the project financed by the Ministry of Foreign Affairs of Finland.

Legal aid to vulnerable and marginalised groups

November, legal aid lawyers provided free legal assistance to 53 beneficiaries. Moreover, on 15 and 16 November, ECMI Kosovo, in cooperation with Albanian and Roma, Ashkali and Egyptian women's organisations, organised 2 training workshops on legal advocacy tools. On 1 and 23 November 2012, ECMI Kosovo supported two NGOs 'Naš Dom' and 'Relax' in organising advocacy round table discussions: first regarding problems of Serb and Roma community members in accessing civil registration in the Gjilan/ Gnjilane region; the second on the lack of access for Bosniak upper-secondary students to books in their mother tongue and the consequent detrimental effects on their education. Finally, ECMI Kosovo submitted a complaint to MEST regarding discriminatory content towards Roma, Ashkali and Egyptian communities in an 8th grade reading textbook.

Support to minority communities during and after the decentralisation process

ECMI Kosovo hosted a delegation of representatives from Finland, who met ECMI's main partners in the North, including civil society organisations and Mitrovica North Administrative Office (MNAO). Support to MNAO was ongoing with the design and publication of a presentation leaflet.
