### **ECMI Kosovo Project Updates**

Trainings delivered to Municipal and School Drop-Out Prevention Teams on Identification and Registration, Case Management, and Interventions for Integration of Outof-School Children

In November, ECMI Kosovo delivered trainings to school and municipal drop-out prevention teams (Prevention and Response Teams towards Abandonment and Non-Registration - PRTAN) of its targeted municipalities Fushe Kosovë/Kosovo Polje, Obiliq/Obilić, Ferizaj/Uroševac, Pejë/Peć, Istog/Istok, Klinë/Klina as well as Gjakovë/Đakovica, which will be included in the future education program.

responding to cases of children out-ofschool and on programming and implementing drop-out prevention and response interventions, as well as monitoring and evaluation. The trainings focused on the mandate and responsibilities of the teams and in introducing a case management system and intervention mechanisms for the integration of out-ofschool children.

The school and municipal prevention teams were provided with tools aimed at supporting their work. Discussions were held on when children are at risk of dropping out, how to register cases of children that dropped out or are at risk of dropping out, how to conduct case management and refer cases to other institutions, and which concrete activities are to be undertaken to integrate out-of-school children. ECMI Kosovo is in the process of finalising a manual for the school and municipal PRTAN teams, designed in cooperation with UNICEF, KEC and MEST.



These activities are part of the project "Enhancing Access to and Retention in Education for Vulnerable and

partnership with UNICEF Office in Kosovo which aims at reducing the numbers of outof-school children in the six mentioned Kosovo municipalities.

## Training sessions with the Municipal Assembly Members

On 6th November in Gračanica/Graçanicë, ECMI Kosovo organized the third training for Municipal Assembly members on their roles and responsibilities regarding the protection and promotion of community rights. The following Municipalities participated this time: Gračanica/Graçanicë and Štrpce/Shtërpcë.

This event marked the completion of the activity targeting newly-elected Municipal Assembly members. The activity targeted a total of eight (8) Municipalities, six (6) of which were Serb-majority Municipalities (Gračanica/Graçanicë, Klokot/Kllokot, Novo Brdo/Novobërdë, Parteš/Partesh, Ranilug/Ranillug, Štrpce/Shtërpcë) and two (2) Albanian-majority (Kamenicë/Kamenica and Viti/Vitina). One of the most interesting elements of this activity was to have different ethnically mixed Municipalities debating openly together on important topics like the implementation of the decentralization process and relations between local and central-level institutions and government.



This event was part of the joint activities within the project 'Towards a Sustainable and Inclusive Growth for All Newly-established Municipalities in Kosovo' funded by the Ministry for Foreign Affairs of Finland and the project 'Promoting Good Governance and Enhancing the Capacity of Kosovo's Newly Established Municipalities in Protecting Community Rights' funded by the UK Foreign and Commonwealth Office (FCO).

## Meeting with the Mayor of Leposavić/Leposaviq

On 18th November, ECMI Kosovo staff involved in the project 'Towards a Sustainable and Inclusive Growth for All Newly-established Municipalities in Kosovo' met the Mayor of Leposavić/Leposaviq to discuss the possible implementation of further activities in the Municipality.

Various topics were discussed during the meeting. In particular, it was very useful for ECMI Kosovo to hear the Mayor's personal considerations about issues regarding municipal relations with the central government. In this regard, his

The Mayor agreed on the importance of offering trainings to local Municipal Assembly members and to increasingly involve the local civil society in capacity building activities. The meeting was concluded reaffirming the commitment of ECMI in providing support to the Municipality according to the organization's capacity and mandate.

## Training in Mitrovica/Mitrovicë North

From 2-3 December, ECMI Kosovo organised a first training session for youth and women in Mitrovica/Mitrovicë North on the topic "Basics of Entrepreneurship" within the project "Towards a Sustainable and Inclusive Growth of all Newly Established Municipalities in Kosovo" supported by the Ministry for Foreign Affairs of Finland. The training is the first in a set of trainings foreseen to be developed with the same group, the aim of which is increasing entrepreneurial and employability skills of the participants. The topics resulted from focus group discussions held in Mitrovica/Mitrovicë North with youth and women, where the need for self-employment and trainings for increasing entrepreneurial and employability skills were identified as a nriority



## Final tests for municipal officials in the official languages

In November, ECMI Kosovo organised final Albanian and Serbian language tests for municipal officials enrolled in the second phase of the six-month official language training courses. The participants in the municipalities of Prizren, Dragash/Dragaš, Fushë Kosovë/Kosovo Polje, Gjilan/Gnjilane, Kamenicë/Kamenica, Lipjan/Lipljan, Novobërdë/Novo Brdo, Shtërpcë/Štrpce, Vushtrri/Vučitrn and Klokot/Kllokot were tested on their achievement in learning one of the two official languages as part of the project aiming to increase the proficiency of municipal officials to communicate in both official languages.

The second phase of Albanian and Serbian language training courses aimed at improving the communication of municipal officials with members of the public, with central-level institutions and with one another started this February in 14 municipalities and will last until December, as part of the project 'Official Language Acquisition for Municipal Officials in Kosovo' funded by the OSCE High Commissioner on National Minorities (HCNM) and the Office

Office of the Prime Minister.

### **OLC'S Meeting of Observers**

On 6 November 2014, ECMI Kosovo participated in the midterm meeting of observers organised by the Office of the Language Commissioner (OLC). This event was held in the Government Building and it aimed to provide an update on the implementation of the OLC's 2014 working plan, and to present and discuss the main activities foreseen for the 2015 action plan with relevant government, international and civil society stakeholders.

Among the current and future activities that were presented, particular emphasis was placed on the activities that are being implemented by ECMI Kosovo in close cooperation with the OLC, namely, the project 'Official Language Acquisition for Municipal Officials in Kosovo' funded by the OSCE High Commissioner on National Minorities and the Office of the Language Commissioner/Office of the Prime Minister; the project 'Official Language Training Courses for the Office of the Prime Minister', funded by the Office of the Prime Minister; and the project 'Monitoring and Evaluation of Language Rights in Kosovo: Towards Strengthening Institutional Compliance with the Kosovo Law on the Use of Languages', funded by the Office of the Language Commissioner of the Republic of Kosovo through the United Nations Development Programme (UNDP)



### The organization of dialogue sessions between CSOs and Municipal Assembly Members

During November, ECMI Kosovo organized a number of dialogue sessions between representatives of minority Civil Society Organisations and Municipal Assembly Members. The aim of the dialogue sessions was to promote the mutual knowledge and communication between the two actors, and open opportunities for cooperation. This activity supported the creation of a transparent and trustful environment between them which will benefit the work of both and have a direct effect on the local citizens. Indeed, local CSOs will act as intermediaries between these and the municipal authorities.

## PDK and LDK agree to form a coalition government after a five-month stalemate

Following a five-month stalemate over the formation of the next government, on 19 November PDK and LDK agreed to set aside differences and form a coalition government. The agreement was struck following increased pressure from bilateral partners to end the stalemate after the rulings from the Constitutional Court made it clear that VLAN (LDK, AAK, Nisma, Vetëvendosje) did not have the right to elect a Speaker of Parliament from its own ranks. LDK had tried to re-negotiate the agreement with its partners in the bloc, but was unable to convince them to re-design the agreement which would allow LDK to lead the government. The PDK-LDK coalition guarantees a comfortable majority in Parliament for the next government (67 MPs without "Lista srpska", also expected to join the government). Working groups from both coalition partners are still working out the details, but it is expected that the government will be led by Isa Mustafa, LDK chairman.

# Alarming increase of Roma, Ashkali, and Egyptians emigration out of Kosovo reported

Kosovo media are reporting on increasing numbers of Roma, Ashkali, and Egyptians individuals and even entire families emigrating to the European Union through illegal channels. While concrete numbers are hard to come by, reports from the field suggest that the number may be as high as 5,000 individuals from all parts of Kosovo. While Kosovo Police have started investigating cases of fraud and smuggling of persons across the border, emigration continues at a high rate. A majority of those interviewed and reports from the field suggest the main reason for emigration is the poor economic conditions of those citizens emigrating. Jablanović has also stated that he expects the Parliament to vote for the establishment of the ACSM first thing after it votes for the creation of the new government.
