**ECMI Kosovo** is pleased to announce a call for participation in a series of training sessions aimed at strengthening the capacities of Civil Society Organizations (CSOs) and institutions to improve migration governance and the rights of migrant workers in Kosovo.

### **Project Description**

**“Strengthening Migration Governance and Civil Society Capacities in Kosovo”** is a project funded by GIZ and implemented by ECMI Kosovo. It aims to enhance the capacities of institutions and civil society organizations to strengthen migration governance and protect the rights of migrant workers in Kosovo.

The project focuses on:

- Building the capacities of public institutions in ethical recruitment, contract transparency, and enforcement of labor rights;
- Empowering civil society organizations to advocate, monitor, and support migrant workers;
- Promoting collaboration between institutions and organizations to address migration challenges.

This initiative is part of broader efforts to create a sustainable and inclusive migration management system, improving social and economic protections for all stakeholders involved.

### **Who Can Apply?**

We invite all civil society organizations and NGOs that:

- Have experience or interest in issues related to labor rights, migration, or vulnerable groups;
- Are willing to engage in advocacy and monitoring activities;
- Operate in Kosovo and aim to contribute to improving conditions for migrant workers.

### **What Do the Training Sessions Offer?**

- **Professional training sessions on:**
  - Ethical recruitment practices;
  - Transparency and monitoring of employment contracts;
  - Laws and policies on migrant workers’ rights;
  - Advocacy and monitoring of working conditions.

- **Practical experience:** Simulations and case studies to apply knowledge in real-world scenarios.
- **Support materials:** Guides, manuals, and tools to assist organizations in their daily work.
- **Financial support:** Opportunities to benefit from a funding program for CSO projects on advocacy and monitoring.
- **Networking and collaboration:** Opportunities to establish new partnerships with governmental institutions and other local and international organizations.
- **Continuous training:** Ongoing capacity-building support as part of the project's sustainable approach.

These training sessions are not limited to the topics mentioned above but represent only some of the many other themes that will be covered during the training sessions within the project. Participants will have the opportunity to explore various relevant issues aimed at enhancing capacities and improving efficiency in migration governance and the protection of migrant workers' rights.

### **Selection Criteria**

- Participants must be representatives of organizations actively engaged in social issues, with experience or interest in advocating for and protecting migrant workers' rights.
- Interested organizations must submit a CV of their organization.
